ORDINANCE AMENDING TRENTON CITY CODE SECTION 2-23D RELATING TO THE POWERS AND DUTIES OF THE CITY ATTORNEY

IT IS HEREBY ORDAINED by the City Council of the City of Trenton as follows:

- 1. Section 2-23D of the City of Trenton Municipal Code, which currently reads "Subject to the approval of the Council, have the power to enter into agreement, compromise, or settlement of any litigation in which the City is involved.", be and hereby is deleted in its entirety.
- 2. A new Section 2-23D is hereby adopted which will read as follows:
 - D. Subject to the approval of the Council, the City Attorney shall have the power to enter into any agreement, compromise, or settlement of any litigation in which the City, its Officials, or Employees are involved. If the total monetary amount od such settlement is \$25,000.00 \$75,000.00 or less, the City Attorney is empowered to conclude the settlement without prior Council approval, expect that in such instance the City Attorney shall provide the Council with a written summary of the matter and the reasons why the settlement was approved by him or her.

IT IS HEREBY ORDAINED that this Ordinance shall take effect pursuant to NJSA 40:69A-181 and other applicable law.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TRENTON ACKNOWLEDGING OCTOBER 5TH – OCTOBER 12TH AS MENTAL ILLNESS AWARENESS WEEK AND OCTOBER 10TH AS NATIONAL MENTAL HEALTH DAY IN THE **CITY OF TRENTON**

WHEREAS, mental illness affects millions of Americans each year, cutting across all age groups, socioeconomic statuses, and racial and ethnic backgrounds, and is a leading cause of disability worldwide; and

WHEREAS, the City of Trenton recognizes that individuals experiencing mental illness are often confronted with stigma, discrimination, and a lack of understanding, which can discourage them from seeking the help and support they need; and

WHEREAS, Mental Illness Awareness Week, recognized annually during the first full week of October, was established to raise awareness of mental illness, educate the public, and combat the stigma surrounding mental health conditions; and

WHEREAS, National Mental Health Day, observed on October 10th each year, brings attention to the importance of mental health and well-being, and encourages individuals to prioritize their mental health and seek resources and care when needed; and

WHEREAS, the City of Trenton is committed to improving the mental health of its residents by supporting community-based mental health services, promoting mental health awareness, and advocating for policies that support individuals with mental illness; and

WHEREAS, acknowledging Mental Illness Awareness Week and National Mental Health Day provides an opportunity for the City of Trenton to stand in solidarity with those affected by mental illness, promote early detection and intervention, and encourage open discussions about mental health to foster a supportive community environment.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Trenton, in the County of Mercer and State of New Jersey, as follows:

Section 1. Acknowledgment of Mental Illness Awareness Week

The City Council of the City of Trenton hereby acknowledges October 5th – October 12th as Mental Illness Awareness Week in the City of Trenton, to raise awareness about mental illness, reduce stigma, and provide education to residents about the realities and challenges faced by those living with mental illness.

Section 2. Acknowledgment of National Mental Health Day

The City Council further designates October 10th as National Mental Health Day in the City of Trenton, in solidarity with the nationwide efforts to prioritize mental health and support the wellbeing of all individuals in our community.

Section 3. Encouragement of Community Participation

The City Council encourages residents, schools, businesses, healthcare providers, and community organizations to participate in activities and programs during Mental Illness Awareness Week and National Mental Health Day that promote mental health education, raise awareness about mental illness, and support individuals affected by mental health conditions.

Section 4. Commitment to Mental Health Services

The City of Trenton reaffirms its commitment to improving access to mental health services, reducing the stigma surrounding mental illness, and promoting policies that support individuals and families affected by mental illness.

Section 5. Public Awareness Campaign

The City Council encourages the promotion of Mental Illness Awareness Week and National Mental Health Day through social media, public service announcements, community events, and partnerships with local mental health organizations to ensure that residents are informed about available resources and services.

WHEREAS, Down syndrome is a genetic disorder caused when abnormal cell division results in an extra full or partial copy of chromosome 21. This extra genetic material causes the developmental changes and physical features of Down syndrome. Down syndrome varies in severity among individuals, causing lifelong intellectual disability and developmental delays. It's the most common genetic chromosomal disorder and cause of learning disabilities in children. It also commonly causes other medical abnormalities, including heart and gastrointestinal disorders; and

WHEREAS, individuals with Down syndrome contribute to our communities in diverse and meaningful ways, and their unique talents, strengths, and abilities enrich the City of Trenton. Recognizing Down Syndrome Awareness Month in the City of Trenton is an important step in advocating for the rights, dignity, and inclusion of individuals with Down syndrome in all aspects of community life, including education, employment, healthcare, and recreation; and
